## Title of the presentation:

Next Directions with Study Abroad: Opportunities for Portuguese and US HEIs

## Description

This session will explore how global experiential learning—through internships, study abroad, service learning, and research—equips students with the skills and perspectives needed to tackle the United Nations Sustainable Development Goals (SDGs). By engaging directly with real-world challenges in diverse cultural and geographical contexts, students develop a deep understanding of global issues such as climate action, poverty alleviation, and social justice. The session will introduce Lehigh's Self-Other-World pedagogy (SOWL) as a framework for global experiential learning, and highlight model programs such as the lacocca Institute's Global Village and the UN Partnership.

## Title of the presentation:

From "Undesirable Organization" in Russia to New Opportunities in Kazakhstan: The Odyssey of an International Office

## Description

Following the Russian Federation's illegal annexation of Crimea in 2014 and full-scale invasion of Ukraine in 2022, the Eurasia Representative Office of IIE faced mounting political challenges which eventually led to its closure in Moscow, Russia and transfer of location to Almaty, Kazakhstan. IIE has established a Kazakh-US University Consortium to develop an international network of HEI's while focusing on STEM,



IT, Renewable Energy, and Agriculture as fields of engagement while developing opportunities for research, commercialization, student and faculty exchange, which could act as pathways for replication for organizations and HEI's in other countries wishing to expand their globalization efforts into one of the world's most strategically and economically significant regions. While Kazakhstan is a landlocked country and Portugal is located on the Atlantic Ocean, there are a number of areas of co-interest worthy of exploration.

## Title of the presentation:

Service-Learning Research Partnerships to Drive Evidence-Based Public Policy

## Description

Too often, universities and policymakers engage with timely, policy-relevant issues in isolation from one another, though the potential for collaboration abounds. In the United States, the desire to bridge this gap has driven higher education's widely shared call for community engagement, university-community research collaboration, and service-learning since at least the 1990s.Yet such partnerships can be challenging to initiate, manage and sustain. Furthermore, while involving student researchers in such partnerships can have transformative effects for all involved, it requires additional layers of intentionality. Dr. Rob Glover has spent over a decade successfully initiating, executing, and sustaining such projects with partners ranging from non-profit organizations to policy advocacy organizations to local government and elected officials. In this presentation, he will share insights and lessons learned from this award-winning work, with particular attention on those seeking to build such partnerships in Portugal. In addition, he will offer initial thoughts on the possibilities for transnational service-learning partnerships between institutions of higher education in the US and Portugal.

Title of the presentation: New shapes of education in HigherEd in an evolving world

#### Description

Higher Education offers scientific, cultural and philosophical assets to society that mere skills training does not. Notwithstanding, employers need employees with diverse and evolving skills. Very quickly, we in Higher Education have learned that having a career requires people to upskill continuously. So, education and experience cannot be decoupled because it is clear that a content-centered approach alone is no longer enough to satisfy the learners' life choices and needs. More flexible higher education systems are better positioned to respond to crises, improve learning and create a significant impact in society. A flexible learning model can be designed to give the freedom of choice where learners can build their learning path from different subject fields while including different forms of learning. At ECIU University, learners engage in Challenge Based Learning (CBL) through real-life challenges and micro-modules, and their skills are documented in a competence passport. Meanwhile the ECIU University offers learner support via the newly developed User Support Services, while Community-building events and online hubs have strengthened connections among students, researchers and teachers. This is underpinned by our emphasis on mobility through the establishment of a mobility fund. Therefore, at ECIU University our starting point is the learner experience, and from there we work backwards, to offer flexible higher education and training with excellence and relevance to our evolving world.
